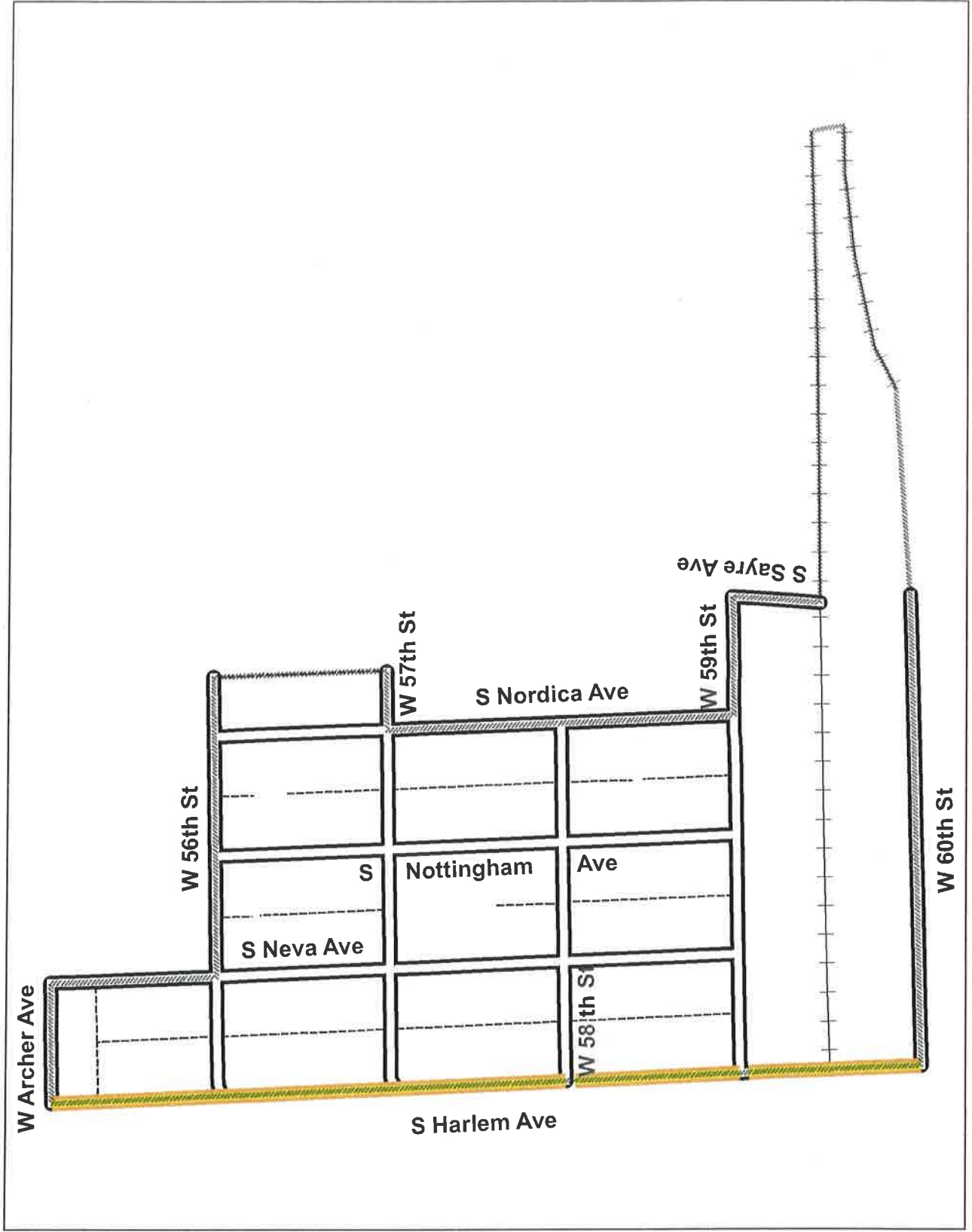








PCT 01 WARD 23

Beginning at the intersection of S. Harlem Av. and W. Archer Av., thence east on W. Archer Av. to S. Neva Av., thence south on S. Neva Av. to W. 56th St., thence east on W. 56th St. to the alley east of S. Nordica Av., thence south on the alley east of S. Nordica Av. to W. 57th St., thence west on W. 57th St. to S. Nordica Av., thence south on S. Nordica Av. to W. 59th St., thence east on W. 59th St. to S. Sayre Av., thence south on S. Sayre Av. to the Indiana Harbor Belt R.R., thence east on the Indiana Harbor Belt R.R. to S. Nashville Av. (extended), thence south on S. Nashville Av. (extended), to the Branch of C R.R., thence southerly on the Branch of C R.R. to W. 60th St. (extended), thence west on W. 60th St. (extended) and W. 60th St. to S. Harlem Av., and north on S. Harlem Av. to the place of beginning.
