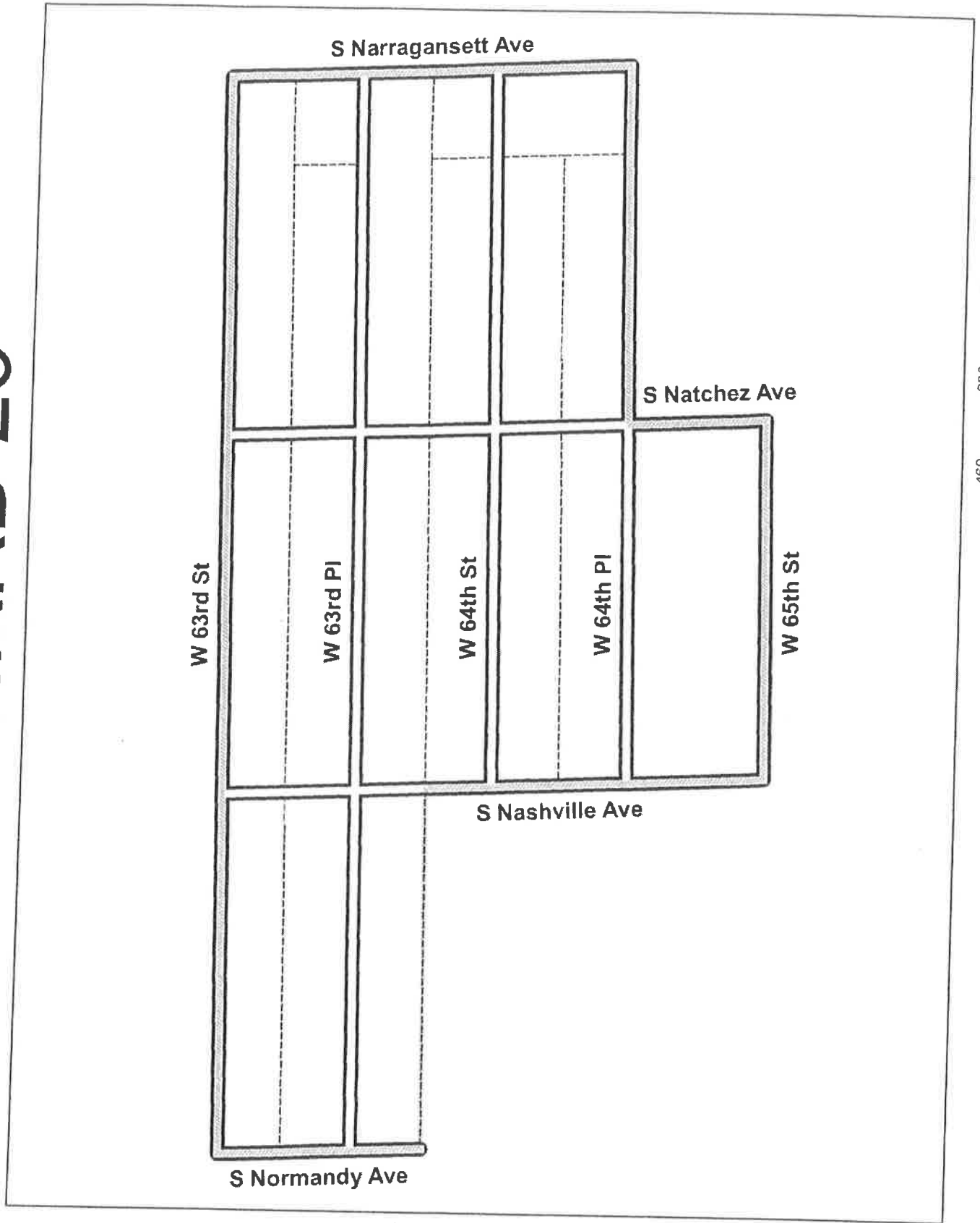









## PCT 23    WARD 23
